VO(cont'd): Please be aware that the options you see here are mandated by law in the form you see here and can neither be added nor changed. Please ensure that when you are collecting your data, you have made adequate allowances for collecting this information appropriately.

(Highlight males and females again, four boxes, one each for race and ethnicity by gender)

VO(cont'd): The numbers in each column and section should relate:...

(female box on ethnicity blinks)

**VO(cont'd):** The total number of females in the Ethnicity section....

(ethnicity stops blinking, female gender box blinks)

VO(cont'd):...must equal the number of females listed under race if all rows in that column are added together.

(females stop blinking, males start)

**VO(cont'd):** Males should sum the same way.

(males stop blinking, highlights continue to remain)

VO(cont'd): If each adds up correctly, both sets of totals,...

(highlight appears to outline the total lines on ethnicity and gender)

**VO(cont'd):** ...race and ethnicity, should be equal.

(fade out table, fade in each of the following timed with speech, each will grow large and take a place on the screen after being crossed out: 1/2, .05, 50%)

VO(cont'd): Please remember that the NIH can only accept whole numbers: no fractions, decimals, or percentages are acceptable in this table.

(Large words appear then cross out: "Unknown")

**VO(cont'd):** Also, be aware that "unknown" is not an acceptable race or ethnicity on this form.
